All beneficiaries should have direct access to Trust and they should be properly recorded on trust Database.
7. You should explain terms, agreements and various policy of trust and its project available on website to every donor and beneficiaries before they obtain our free or paid support or make decision regarding donation.
8. Additional terms, policy may be added and communicate to you in writing or through email.
9. Commissioner is paid in percentage or in rupees per donation or referral. In Each Donor or beneficiaries you refer, will be your responsibility until the closing of our support to the respective party. Failing to do so may affect your commission. The construction, validity and performance of this agreement shall be governed in all respect by Indian laws and both parties agree to submit to the jurisdiction of the courts of Surat, Gujarat, India.
